For the Aspiring Trade Professional

In today's digital world, protecting your online accounts is more important than ever. Here's the good news: Being a member of NCPD FCU gives you an extra layer of protection.

Online Banking and the NCPD FCU Mobile Banking App are powerful tools in the fight against cybercrime. They boast advanced security features and real-time monitoring to keep your finances safe.

Signs That Someone Hacked Your Account

Hackers might want to steal your personal information to commit identity theft. Others might want to spread malware or scam others. Here are some clues that someone hacked your account:

- · You can't log in to your account.
- You get a notification about a change to your username or password, but you didn't make that change.
- You get a notification that someone logged into your account from a device you don't recognize or a strange location.
- Your friends or family report getting emails or messages you didn't send.

How to Get Back Into Your Hacked Account

Make sure your computer security software is up to date, then run a scan. If the scan identifies suspicious software, delete it, and restart your computer.

Take Steps to Secure Your Account

- 1. Change your account password. Create a strong password that is hard to guess.
- 2. Sign out of all devices.
- 3. Turn on two-factor authentication (2FA), also known as two-step verification.
- 4. Check your account recovery information. Make sure the recovery email addresses and phone numbers listed are ones you entered and have access to.

Check for Signs That Someone Had Access to Your Account

- Check your email settings to see if there are rules set up to forward emails. Delete any rules you didn't set up, so your messages aren't forwarded to someone else's address.
- Check your sent folder for emails the hacker sent from your account. Look in your deleted folder for emails the hacker may have read then deleted.
 Always check your banking accounts using our Mobile Banking App and Online Banking dashboard to confirm all transactions are valid.



Don't Miss Out on Your Key to Homeownership

NCPD FCU is excited to announce, in cooperation with the Federal Home Loan Bank of New York (FHLBNY), a first-time homebuyer program for our members called the **Homebuyer Dream Program**®.

With this program, you may qualify for a **grant of \$19,500** to apply toward closing fees. Grants allotted to NCPD FCU are limited and will be granted on a first-come, first-served basis. Don't hesitate, apply today!

Get started by submitting a complete Mortgage application by **October 1, 2024**. Your application must include a copy of the sales contract and be approved by NCPD FCU.

Our Loan Officers will reach out to you if you have qualified for this grant.

To qualify for this grant you must:

- · Be a first-time homebuyer
- Have a household income of less than \$147,744 if the property being purchased is in Nassau/Suffolk County*
- Complete a housing counseling program such as a webinar or Zoom call lasting 1-2 hours
- Agree to stay in the house for at least 5 years after closing**

There is also a Homebuyer Dream Program® Plus. The HDP® Plus program is available for members with a household income of less than \$221,616, if the property being purchased is in Nassau/Suffolk County.^

*If located in Westchester, household income must be less than \$140,928. If located in Queens/Brooklyn/ Staten Island/NYC, household income must be less than \$135,552.

^If located in Westchester, household income must be less than \$211,392; if located in Queens/Brooklyn/ Staten Island/NYC, household income must be less than \$203,328.

^{**}Borrowers who do not stay in the house for at least 5 years after closing must pay back all or part of the granted funds.
