Fall is the perfect time to start thinking about your financial goals for the coming year. If you're looking for a way to consolidate debt, make home improvements, or finance a major purchase, a home equity loan or line of credit from **NCPD FCU** can be a great option.

A **Conventional Home Equity Line of Credit** has a low introductory rate for two years then adjusts to the prime rate.\* An **Interest Only Home Equity Line of Credit** has variable rate interest only payments for the first ten years of the draw period. Both options let you borrow up to 70% of the appraised value of your home\*\*, have no annual fees, no closing fees for loans up to \$250,000^, and have a minimum loan amount of \$25,000 with a 10-year draw period and a 15-year repayment period.

A **Home Equity Loan** is a lump sum that you receive with a fixed interest rate over a fixed amount of time.

- You may borrow up to 70% of the appraised value of your home less any first mortgage balance
- Minimum loan amount of \$25,000 and the maximum term is 15 years

A new wave of phone scams are coming from people claiming to be from **Apple** or **Amazon**. These scammers will often say there is a problem with your account, a suspicious purchase, a lost package, or an order they can't fulfill and that you need to provide them with personal information or payment details to fix it.

#### What to watch out for:

The caller will often be aggressive and demanding. They may use scare tactics, such as saying that your account has been hacked or that there is a problem with your credit card. They may ask for your Social Security or credit card numbers, or ask you to install software on your computer.

#### If you get one of these calls:

Hang up immediately. Do not provide any personal information or payment details, and do not install any software. If you are concerned about your account, contact Apple or Amazon directly using the phone number or email listed on their official website

You can also report the scam to the Federal Trade Commission at **ftc.gov/complaint**.

By being aware of the scam and taking steps to protect yourself, you can help to keep your personal information safe.
